C&G Update on Matters Outstanding from Previous Meeting

A skip will be placed at Sunderland Road allotments in April and a skip had already been delivered to Lee terrace allotments.

A 'pergola' type shelter had been placed at the entrance of the allotments by persons unknown. It was in good order, and it was recognised that it was for allotment holders to place surplus produce for those that need it.

The access track within SR allotments needs attention. This will be programmed in. Road planings will be used for repairs.

It was noted that repairs may be needed to certain parts of the external fence to SR allotments. This would be identified during the forthcoming inspections.

The village green playground equipment had been repaired after much delay by HAGS.

Wild-flower seeds would be planted around the village shortly.

The Clerk was to meet with the DCC arborist on Thu 14 March to discuss the state of various trees around the village.

The Clerk would investigate the availability of S106 funding for a number of projects associated with the cemetery and grounds around the village.
